- (1) I, Sudhansu Sekhar Panigrahi, Practicing Company Secretary (ACS 23187 /CP 19649) was appointed as Scrutinizer by the Company in connection with the 37th Annual General Meeting of the members of SMIFS Capital Markets Ltd (herein after called "Company") held on 5th September, 2020 through Video Conferencing ("VC")/Other Audio-Visual Means ("OVAM") at its registered office at Vaibhav, 4F, 4 Lee Road, Kolkata 700 020 at 10.00 A.M. for the purpose of scrutinizing the e-voting and voting through physical ballots process in a fair and transparent manner and ascertaining the requisite majority for the said voting as per the provisions of the Companies Act, 2013 and Rule 20 of the Companies (Management and Administrations) Rule, 2014 as amended on the resolutions referred to in this report.
- (2) The management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013 and Rules relating to E-Voting and voting through physical ballot process on the resolutions contained in the Notice of Annual General Meeting dated 30th June, 2020. My responsibility as a scrutinizer for the voting process through electronic means and physical ballots is restricted to make a Scrutinizer's Report of the votes cast "in favour" or "against" the resolutions, based on the report generated from the e-voting system of Central Depository Services (India) Ltd (CDSL) and of voting through physical ballots as provided by M/s Maheshwari Datamatics Private Limited, Kolkata the agencies engaged by the Company to provide e-voting and physical ballot facilities.
- (3) I submit the report as under:
 - i. The remote e-voting period remained open from 10 a.m. IST on Tuesday the 1st day of September, 2020 up to 5 p.m. IST on Friday the 4th day of September, 2020.
 - ii. The share holders holding shares as on the "cut off" date i.e. 29th day of August, 2020 were entitled to vote on the proposed 2 (Two) resolutions as mentioned in the Notice dated 30th June, 2020 of the Annual General Meeting of the Company.
 - iii. The Company has also allowed e-voting facility at the venue of the Annual General Meeting to enable the share holders to cast the vote in case the same has not been casted by them through remote e-voting.
 - iv.
